

# "CIRCLE ELYSÉES" VIP CLUB – Terms and Conditions

Please take the time to read these terms and conditions. By participating in the "Circle Elysées" VIP Club ("Circle Elysées" or the "VIP Club") and/or enjoying the benefits and privileges offered by or through the VIP Club, you will be deemed to have accepted these terms and conditions.

These terms and conditions govern the operation of "Circle Elysées" and its memberships and are binding on all members of the VIP Club. "Circle Elysées" is operated by AXA China Region Insurance Company Limited ("AXA China Region") for and on behalf of AXA Hong Kong ("AXA"). AXA reserves the right to change any terms and conditions of and relating to "Circle Elysées" from time to time.

Each member of "Circle Elysées" agrees that he/she has:

- (i) read, understood and accepted these terms and conditions and any amendments made to these terms and conditions from time to time, and that participation in the "Circle Elysées" membership will constitute an acceptance of these terms and conditions and such amendment, modification or supplementation from time to time;
- (ii) understood and accepted the arrangement with respect to the collection, use, retention, access of his/her personal information as set out in this document and also in AXA's Privacy Policy Statement which is accessible through the designated website(s); and
- (iii) assumed the responsibility to keep up-to-date with all the relevant terms and conditions (including any amendments made) provided by AXA in respect of "Circle Elysées" through whatever means of communication.

## 1. "Circle Elysées" Membership

### 1.1 Eligibility

"Circle Elysées" membership is by invitation only. Selected customers who hold in-force policy(ies) with AXA and who meet all of the entry requirements of "Circle Elysées" will automatically become a member of "Circle Elysées". ### 1.2 Membership Period and Renewal

"Circle Elysées" membership is valid up to a year depending on the month and year the customer becomes a "Circle Elysées" member. The "Circle Elysées" membership will be renewed annually at the absolute discretion of AXA.

### 1.3 Membership Termination

If a "Circle Elysées" member no longer holds any in-force policy with AXA, his/her "Circle Elysées" membership may be terminated immediately. AXA reserves the right to terminate any "Circle Elysées" membership at its discretion if a member is found to have misused the membership privileges.

AXA reserves the right to change the benefits and privileges offered by or through "Circle Elysées" at any time without notice. In the event of any dispute, AXA's decision shall be final and conclusive.
