親愛的客戶：

東方匯理系列基金 - 歐元高回報債券基金 (「受影響投資選擇」) 之暫停交易及估值

根據東方匯理系列基金的董事局 (「董事局」) 通知，**Structura - European High Yield Bond** 將合併至**東方匯理系列基金 - 歐元高回報債券基金**，即受影響投資選擇的參考基金 (「參考基金」)。該合併 (「合併」) 將於**2026年5月7日**生效。請注意，Structura - European High Yield Bond 未經香港證券及期貨事務監察委員會認可向香港公眾銷售，本通知書並無向香港公眾作出有關該基金的要約。

參考基金的投資目標、投資政策、風險狀況、費用及特點不會因合併而有所改變。

為方便合併及確保合併順利進行，董事局根據東方匯理系列基金組織章程細則第 33 條並經徵詢東方匯理系列基金之存管處的意見，已決定參考基金於**2026年5月6日** (香港時間) 不接納認購、贖回、轉讓及轉換指令。為免生疑問，在上述期間不會暫停參考基金的資產淨值計算。自2026年5月7日 (香港時間) 起，參考基金將恢復正常接納認購、贖回、轉讓及轉換指令。董事局相信此項暫停符合參考基金股東的最佳利益。

由於參考基金暫停交易，**受影響投資選擇將於2026年5月6日暫停交易 (包括分配、註銷或轉換) 及估值**。交易及估值將於2026年5月7日恢復正常。

若閣下是受影響投資選擇的投資者，**如閣下接受上述變更，則毋須作任何行動**。如閣下不接受上述變更，閣下可 (i) 轉換閣下現有受影響投資選擇之名義單位到計劃下的其他投資選擇，相關轉換將不會被收取轉換費；及 / 或 (ii) 將閣下未來於受影響投資選擇所作之投資選擇重新分配至計劃下的其他投資選擇，而我們不會就此徵收費用。

Dear Valued Customer,

Suspension of dealings and valuation of Amundi Funds - Euro High Yield Bond (the “Affected Investment Option”)

As informed by the board of directors of Amundi Funds (the “**Board of Directors**”), **Structura – European High Yield Bond** will be merged into **Amundi Funds – Euro High Yield Bond**, which is the reference fund (the “**Reference Fund**”) of the Affected Investment Option. The merger (the “**Merger**”) will take effect on **7 May 2026**. Please note that Structura – European High Yield Bond is not authorized by the Hong Kong Securities and Futures Commission for sale to the public in Hong Kong, and no offer is made to the public of Hong Kong in respect this fund herein.

There will be no changes to the investment objective, investment policy, risk profile, fees and characteristics of the Reference Fund as a result of the Merger.

In order to facilitate the Merger and ensure its smooth execution, the Board of Directors, in accordance with article 33 of the articles of incorporation of Amundi Funds and in consultation with the depositary of Amundi Funds, has decided that the Reference Fund will not be accepting orders for subscriptions, redemptions, transfers and switches on **6 May 2026** (Hong Kong time). For the avoidance of doubt, the calculation of the net asset value of the Reference Fund will not be suspended during the aforesaid period. As from 7 May 2026 (Hong Kong time), the Reference Fund will resume normally accepting orders of subscriptions, redemptions, transfers and switches. The Board of Directors believes that such a suspension is in the best interests of shareholders of the Reference Fund.

As a result of the suspension of dealings of the Reference Fund, the **dealings (including the allocation, cancellation and switching) and valuation of the Affected Investment Option will be suspended on 6 May 2026**. Dealings and valuation will resume to normal on 7 May 2026.

If you are an investor of the Affected Investment Option, **no action is required if you accept the above change**. If you do not accept the above change, you may: (i) switch your existing notional units in the Affected Investment Option to other investment option(s) available under the Scheme free of switching fee; and/ or (ii) redirect your future investment option allocation in the Affected Investment Option to other investment option(s) available under the Scheme free of charge.
